TERMS AND CONDITIONS

THESE TERMS AND CONDITIONS APPLY TO SUBSCRIBERS OF E-ESTONIANS VPN SERVICE.

1. This is an agreement between subscriber (hereinafter You) and **e-Estonians** (hereinafter **e-Estonians**) for virtual private network communications services, related services and features. By using and/or visiting the **e-Estonians** service and **e-Estonians** website (collectively, including but not limited to all services and webpages available through **e-Estonians**, the website) subscriber agrees in full to the terms and conditions provided herein. **e-Estonians** services are NOT services for the commission of criminal acts, they are privacy services. Virtual private network is granted to you upon authentication through Estonian ID-card or Estonian e-residency digi-ID card. You agree not to violate any laws of any jurisdiction you are originating from, or terminating into.

RESPONSIBILITIES

- 1. As the ID-card or digi-ID used for authentication is tied to Your personality, the account for using **e-Estonians** services is intended only for personal use by You. You are solely responsible for all the actions, that occur on our servers where the login uses your ID-card or Digi-ID.
- 2. You agree not to use the system for sending spam, port scanning, scanning for open proxies or open relays, sending opt-in email, unsolicited email or any type or version of email sent in large quantities even if the email is ultimately sent off of another server. You agree not to launch any pop-ups from our service. You agree not to attack in any way shape or form any other computer or network while on our service.
- 3. **e-Estonians** services enable and allow You to bypass government and ISP censorship. If you use the service from a country which performs censorship by law, you understand and accept that you bypass censorship under your own responsibility.
- 4. **e-Estonians** services enable and allow You to use applications forbidden by your ISP and/or by your government. If You use the service from a country which forbids applications by law, and/or from an ISP which discriminates against services and/or protocols and/or applications and/or packet senders and/or packet receivers, You understand and accept that you operate under Your own responsibility.

REMUNERATION

1. **e-Estonians** offer a free test trial and two subscription plans. Subscription fees will be collected on a monthly or yearly basis. Payments will be accepted through national bank links or credit cards. Refunding of payments made will be subject to Refund Policy.

PRIVACY

1. As opposed to anonymous VPN services, **e-Estonians** service is subject to authentication through national ID-card or e-residents digi-ID card. **e-Estonians** does not log your actions or monitor your sessions. Detailed privacy issues and data collection and retention are subject to Privacy Policy of e-Estonians VPN.

TERMINATION OF SERVICES

- 1. These Terms and Conditions will continue to apply until terminated by either You or **e-Estonians**, as set out below:
- 2. **e-Estonians** may terminate its legal agreement with you at any time, if:
 - a. You have breached any provision of the Terms and Conditions (or have acted in a manner that does not show your intent to comply with the provisions of the Terms and Conditions or you are no longer able to comply with the provisions of the Terms and Conditions).
 - b. You have breached any obligations You have undertaken with these Terms and Conditions.
 - c. **e-Estonians** is required to do so by law.
 - d. Your ID-card or digi-ID is no longer valid or You have been deprived from the right of being an e-resident of Estonia.

CHANGES TO THIS AGREEMENT

1. You understand, that the present Terms and Conditions are subject to changes made by **e-Estonians** at any time at its sole discretion, and You agree to be bound by any and all modifications, changes and/or revisions. You understand that it is your obligation to periodically review this webpage in order to account for any changes made, as they will be binding upon assent.

SEVERABILITY

1. If any provision of these Terms and Conditions is held to be unlawful, void, or for any reason unenforceable, then that provision will be limited or eliminated from the text of Terms and Conditions to the minimum extent necessary and will not affect the validity and enforceability of any remaining provisions.

GOVERNING LAW AND JURISDICTION.

1. These Terms and Conditions will be governed by and construed in accordance with the Estonian jurisdiction and the courts in Estonia. You hereby consent and submit to the personal and exclusive jurisdiction of courts in Estonia for the purposes of litigating any action.
